**Piazza Area:**

3X3	\$60 + \$10 power lead (15amp)
4X3	\$80 + \$10 power lead (15amp)
6X3	\$100 + \$10 power lead (15amp)

- 20% discount on monthly upfront payments paid on the Tuesday before Market day.
- 30% discount on 6 months' upfront payment paid on the Tuesday before first Market day (4<sup>th</sup> of May 2019)

Stallholders must comply with Work safe/electrical/gas safety regulations and bring their own lighting after sunset.

We highly encourage you to use solar powered lights so you will not need to access a power outlet and be charged \$10.

- 1. All power leads and electrical equipment must have a current test tag attached by a qualified electrician.*
- 2. All gas equipment must have a current compliance plate.*
